website where the Official Transcripts will be presented via PDF. In addition to the email address, you will need to provide the name and address of the recipient. It is your responsibility to notify the recipient that you requested

To order your transcripts online, your identity must be validated.

- Cost
 - > Paper transcript: 72 cents to produce, including postage
 - > Electronic transcript: zero
- Transcripts Produced (year-to-date)
 - > 17% electronically delivered (fax or email)
 - 21% so far in April
 - > Over 700 faxed transcripts
- Online Orders (year-to-date)
 - > 23% requested electronic delivery
 - Started at 16% last November with no advertising
 - 30% so far in April
